This is with reference to SEBI circular bearing reference no. SEBI/HO/DDHS/CIR/P/2018/144 dated November 26, 2018 and BSE circular bearing reference no. LIST/COMP/05/2019-20 dated April 11, 2019, in respect of fund raising by issuance of debt securities by large entities.

In this regard, kindly note that as per the applicability criteria given under the SEBI circular bearing reference no. SEBI/HO/DDHS/CIR/P/2018/144 dated November 26, 2018, Tower Infrastructure Trust ("Trust") does not fall under the Large Corporate category as on March 31, 2021.

Further, the Trust has not issued any specified securities or debt securities or non-convertible redeemable preference share in terms of Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulations, 2015 during the financial year 2020-21 and does not have any outstanding borrowing as on March 31, 2021.
